MINUTES OF A SPECIAL MEETING OF THE BOARD OF EDUCATION OF THE METROPOLITAN SCHOOL DISTRICT OF NORTH POSEY COUNTY, INDIANA

HELD APRIL 11, 1991

A special meeting of the Board of Education of the M.S.D. of North Posey County, Indiana, was held in the office of the Superintendent of Schools on the 11th day of April, 1991, at the hour of 5:15 P.M., with Board Members Buecher, Lewis, Baehl and Saxe present. Also attending were Superintendent Brenton and Administrative Assistant Rapp.

At 5:15 P.M. it was the Board's decision to go into an Executive Session to discuss employment recommendations.

The Board secured from Executive Session at 6:20 P.M.

The meeting was called to order by President Buecher.

Personnel Recommendations

Upon the recommendation of the Superintendent, on a motion made by Baehl, seconded by Saxe and unanimously carried, the Board approved the appointments of Daniel Ellis and Danny Martin to assume the positions as co-maintenance supervisors, effective April 15, with each sharing the responsibilities for maintenance supervisor formerly handled by the retiring Robert Smith.

It was the unanimous decision of the Board to employ Doyle Marvel as a full time custodian, effective April 15, 1991, assuming the custodial duties formerly assigned to Danny Martin.

Personnel Recommendations - 1991-92

President Buecher explained that it was the feeling of the Board that there was no need at the present time to announce any reduction-in-force in personnel or programs. He further explained that the Board is still optimistic that the Indiana General Assembly would come through with enough revenue prior to their adjournment that would permit the district to maintain its present staff and programs. Mr Buecher explained that the Board would take a final look at the district's financial situation for the 1991-92 school year on April 29th with the hope the legislature will have adjourned by this date.

Patron's Concerns

A group of fourteen parents were present to express their concerns to the Board concerning the possibility of a reduction-inforce in staff and programs for the 1991-92 school year due to the financial picture coming out of the Governor's office in Indianapolis. The spokespeople for the parent group expressed to the Board that they explore all ther possible budgeting cuts before considering the necessity of cutting present staff members or programs. Mr. Buecher expressed a thank you to the parent group for attending the meeting and assured them that the Board would only consider a reduction-in-force and programs as a last resort budgeting cut.

Teacher Recognition

Mr.Brenton reported to the Board that Andrea Crawford, a former English student of Patricia Hewig at North Posey High School, had nominated Mrs. Hewig for the "Doughlian Award" for outstanding teacher of high school English. The "Daghlian Award" is awarded annually by the Indiana University Department of English. Mr. Brenton further reported that Mrs. Hewig was selected as the recipient of the award and would be presented with a \$500.00 cash award at Awards Day Ceremonies to be held on the campus of Indiana University on April 12, 1991.

Band Camp

On a motion made by Baehl, seconded by Saxe and unanimously carried, the Board approved the request of Terri Palmer to chaperon members of the North Posey High School Band to attend band camp at Eastern Illinois University in Charleston, Illinois on July 28 through August 2, 1991.

Request for Legal Transfers

Upon the recommendation of the Superintendent, a motion made by Saxe, seconded by Baehl and unanimously carried, the Board approved legal transfer tuition requests for nine (9) students desiring to attend vocational classes in the Evansville-Vanderburgh School Corporation for the 1991-92 school year. A copy of the request with the students names shall be made a part of the minutes by incorporation.

Request of Diane Smith

On a motion made by Baehl, seconded by Saxe and unanimously carried, the Board approved Diane Smith's request to chaperon nine North Posey High School students to Ben Davis High School in Indianapolis to participate in the National Forensic League Solo Meet on April 12-13, 1991 and to chaperon four students to Perry Meridian High School in Indianapolis on April 20, 1991 to participate in the National Forensic League Congress.

As there was no further school business to come before the Board atthis time the meeting adjourned at $7:25\ P_*M$.
