MINUTES OF A REGULAR MEETING OF THE BOARD OF EDUCATION OF THE METROPOLITAN SCHOOL DISTRICT OF NORTH POSEY COUNTY

HELD SEPTEMBER 9, 1991

The regular meeting of the Board of Education of the M.S.D. of North Posey County, Indiana, was held in the office of the Superintendent of Schools on the 9th day of September, 1991, at the hour of 6:00 P.M., with Board Members Lewis, Baehl, Saxe, Krietenstein and Buecher present. Also attending were Superintendent Brenton and Administrative Assistant Rapp.

At 5:00 P.M. it was the decision of the Board to go into an Executive Session to discuss personnel and other administrative matters. The Board secured from Executive Session at 5:15 P.M.

The meeting was called to order by President Lewis, who presided. Minutes of the previous meetings of August 12, and August 29, 1991 were read to the board and approved as read.

Claims

Upon the recommendation of the Superintendent, on a motion made by Krietenstein, seconded by Baehl and unanimously carried, the Board approved the employment of Sharon Grisham as an elementary library assistant for the 1991-92 school year. Mrs. Grisham is to work three hours per day.

The Board set the date for the dedication of the new addition at North Elementary School for Tuesday, September 24, 1991 at 7:00 P.M.

Pupil Transportation Report

Mr. Rapp reported to the Board that all of the district's school buses passed inspection at the annual school bus inspection conducted by the Indiana State Police on August 12, 1991. He further reported that Bus Evacuation Drills had been completed at North Elementary and South Terrace Elementary and that he expected drills to be completed at North Posey Jr-Sr High School by the end of the week.

Briggelar (a senior at North Posey H.S.) for the 1991-92 school year due to extraordinary circumstances which necessitate that he work a full-time job and attend school one-half day.
