# MINUTES OF A REGULAR MEETING OF THE BOARD OF EDUCATION OF THE METROPOLITAN SCHOOL DISTRICT OF NORTH POSEY COUNTY, INDIANA

HELD JULY 5, 1994

The regular meeting of the Board of Education of the M.S.D. of North Posey County, Indiana, was held in the Office of the Superintendent of Schools on the 5th day of July, 1994, at the hour of 5:30 P.M., with Board Members Baehl, Beucher, Lewis, Seibert, and Mauck, Superintendent Brenton, Administrative Assistant Rapp, and School Attorney Bender in attendance.

At 5:30 P.M. it was the decision of the Board to go into an executive session to discuss applicants for the position of Assistant Principal at North Posey High School and other personnel matters. The Board secured from executive session at 6:24 P.M.

# Oath of Office - Kathy Mauck and Mark Seibert

School Board Attorney, William Bender, administered the oath of office to Kathy Mauck and Mark Seibert, who had been elected to the Board in the May primary election. Members of the Board, Mr. Brenton and Mr. Rapp welcomed aboard Mrs. Mauck and Mr. Seibert following the oath-of-office ceremony.

## Election of Officers

School Board Attorney, William Bender, conducted the election of officers for the fiscal year 1994-95. Member Lewis nominated Baehl for president and Baehl nominated Buecher for president. There were no other nominations and Baehl was elected by a secret vote. Lewis nominated Buecher for Vice-President, there being no other nominations, Buecher was unanimously elected by a voice vote. Buecher nominated Lewis for Secretary. There being no other nominations, Lewis was unanimously elected by a voice vote.

A motion was made by Baehl and seconded by Lewis to reappoint Eudora Hopf as treasurer of the school district. She was unanimously elected by a voice vote.

On a motion made by Lewis, seconded by Buecher, with Baehl and Seibert voting "aye" and Mauck voting "nay", William Bender was eappointed School Board Attorney for a retainer fee of \$50.00 per month for the fiscal year 1994-95.

## Regular Meeting

The regular meeting was called to order by President Baehl, who presided. Minutes of the previous meeting of June 13, 1994 were read to the Board and approved as read.

#### Claims

A copy of the claim docket was presented to the Board for their consideration and upon a motion made by Lewis, seconded by Buecher and unanimously carried, it was approved. A copy of the approved claim docket shall be made a part of the minutes by incorporation.

#### Assistant Principal Applicants

It was the unanimous decision of the Board to interview the three finalists for the assistant principal's position at a special meeting scheduled for July 25th, with an executive session at 5:30 P.M. and the regular meeting for 7:00 P.M.

# Resignation of Assistant Volleyball Coach

The Board reluctantly accepted Stacy Lewis' letter of resignation as assistant volleyball coach at North Posey High School. A copy of Ms. Lewis' letter of resignation shall be made a part of the minutes by incorporation.

## Teacher Request- Lisa Koester

On a motion made by Mauck, seconded by Baehl, and unanimously carried the Board approved Lisa Koester's request to attend The Institute for the Study of Developmental Disabilities summer workshop at Indiana University on August 1-5, 1994.

#### Approval of 4R's Computer Grant

Mr. Brenton informed the Board that the district's petition to the Indiana Department of Education for Project 4R's 1994 at South Terrace Elementary was selected for grant funding in the amount of \$19,989, with a local contribution of \$19,993, for a total budget of \$39,982. A motion was made by Mauck and seconded by Seibert to accept the grant award. Board Member Buecher explained that he had not had a chance to review the grant application and stated the grant guidelines may require curriculum changes which would not have been approved by the Board. Buecher further stated he was not against the grant application but was requesting time to review it before voting. Following a discussion among the board members, it was the unanimous decision of the Board to table the acceptance of the grant until their next meeting on July 25th.

#### North Posey H.S. Marching Vikings

Mr. Brenton reported to the Board that the North Posey Marching Vikings were expected to arrive home during the evening from Washington D.C.. Sharon McCurty who was present reported that she had received phone calls daily and informed the Board that the band performed well and there had been no problems arise from the planned agenda for the trip.

#### Math Class Enrollments

Mr. Brenton informed the Board that the enrollment in math clases at North Posey H.S. were up and that he may be requesting the employment of a teacher for two periods a day at a later meeting date prior to the start of the 1994-95 school year.

# Elizabeth Mumford's Request

Elizabeth Mumford requested an additional year of maternity leave (1994-95 school year) and on a motion made by Seibert, seconded by Mauck and unanimously carried, Mrs. Mumford's request was granted.

## Drug Free Posey County I Care Hotline

After a brief discussion and on a motion made by Buecher, seconded by Lewis, and unanimously carried the Board approved the adoption of the Drug Free Posey County I Care Hotline County Program for our school community. The Board requested that Beverly Kahle, who is the representative for our school community, come to a Board meeting to explain the details of the program.

# Johnson Control

Mr. Brenton gave the Board and update on the work being done by Johnson Control. On a motion made by Buecher, seconded by Seibert and unanimously carried the Board gave Mr. Brenton the authority to sign all forms needed to Johnson Control on behalf of the district, with the recommendation of Mr. Bender (school attorney).
