# Minutes of the Regular Meeting of the Board of Education of the Metropolitan School District of North Posey County, Indiana

# Held on September 8, 1997

The regular meeting of the Board of Education of the M.S.D. of North Posey County, Poseyville, Indiana, was held in the Board Room at the Office of the Superintendent of Schools on the 8th day of September, 1997. The meeting began at the hour of 5:45 p.m. The following Board members were present: Mr. Baehl, Mr. Lewis, Mrs. Mauck, and Mr. Seibert. Also present were Ernest W. Rapp, Superintendent, and John D. Wood, Administrative Assistant.

At 5:45 p.m., it was the decision of the Board to convene in Executive Session for the purpose of IC 5-14-1.5-6.1(8). The Board adjourned from Executive Session at 6:29 p.m.

The Board of Education reconvened for the regular meeting at 6:30 p.m. The meeting was called to order by President Baehl. Minutes of the previous meeting held on August 12, 1997, were submitted to the Board and approved on a motion by Mr. Seibert, seconded by Mr. Lewis, and unanimously carried.

# Public Hearing on 1998 Budget

Mr. Rapp addressed the Board on the procedure for the public hearing on the 1998 Budget. The Budget has been properly advertised. Mr. Rapp asked the individuals attending the meeting if any of them were present to ask questions about the 1998 Budget. No one indicated they had any questions. Mr. Rapp instructed Mr. Baehl to close the Budget Hearing and proceed with the regular meeting agenda.

#### **Poseyville Autumnfest**

Mr. Rapp introduced Jane Hoehn and Rita Martin, representing the Poseyville Autumnfest Planning Committee. Spokesperson, Rita Martin, announced the 1997 Poseyville Autumnfest will be held September 26-28, 1997. She requested permission from the Board to use the two (2) baseball fields at North Elementary School for the Poseyville Jaycees Autumnfest volleyball tournament. Also, Ms. Martin asked to use the parking lot at North Elementary School as a location for the carnival rides during the fest. A third request was for permission to use the front entrance area to North Elementary School for a variety show. Ms. Martin assured the Board proper care of the facilities would be taken and that the Poseyville Autumnfest Committee will be responsible to repair any damages. Ms. Martin stated a certificate of insurance will be provided by the Poseyville Autumnfest Committee and by the carnival ride owner/operator. On a motion by Mr. Seibert, seconded by Mrs. Mauck, the Board unanimously granted the requests.

Mr. Rapp complimented Nancy Dougan and the cafeteria staff of North Posey High School on the preparation and serving of breakfast. Mr. Rapp praised the keynote speaker, Mr. Bob Parks, for his outstanding humorous and motivational presentation. Everyone in the audience truly appreciated his message.

Mr. Rapp informed the Board the date for the OPEN HOUSE activities at North Elementary School will be Monday, September 15, 1997, at 7:00 p.m. South Terrace Elementary School will have OPEN HOUSE on Tuesday, September 16, 1997, at 7:00 p.m.

Mr. Rapp provided the Board with preliminary figures on the ADM for the school district as of September 4, 1997. The projected ADM for each school is as follows:

Mr. Rapp advised the Board that these figures indicate a projected drop in the ADM of 26.5.

# Recommendation of Jr. High Girls' Basketball Coach

Mr. Rapp recommended to the Board the hiring of Michele Taylor as the girls' basketball coach at North Posey Jr. High for the 1997-98 season. On a motion by Mrs. Mauck, seconded by Mr. Lewis, the recommendation unanimously carried.

# Recommendation of Volunteer Assistant Football Coach at North Posey High School

Mr. Rapp asked the Board to approve the assignment of Marc Mitchell as a volunteer assistant football coach at North Posey High School for the 1997 season. This appointment is pending the receipt of a criminal background check now required by law for all individuals approved by the Board to work with students. On a motion by Mr. Seibert, seconded by Mrs. Mauck, the motion unanimously carried.

#### Request Permission to Purchase New 15 Passenger Van

Mr. Wood presented the Board with the final purchase price for 1998 Chevy Express 15 passenger van. The price quotation was provided by Mr. Dave Maloney, sales representative from Dan Young Chevrolet, Inc., 3210 East 96th Street, Indianapolis, IN This dealership was granted the State of Indiana bid purchase price for all public municipalities and represents the best possible price available. The purchase price delivered to Poseyville is \$24,138.89. This price includes all options specified. Mr. Wood recommended the Board approve the purchase of this van. On a motion by Mrs. Mauck, seconded by Mr. Lewis, the Board unanimously approved the recommendation.

#### **Legal Transfer Tuition Requests**

Mr. Rapp asked the Board to approve the legal transfer requests by the following students from North Posey High School to attend the T & I classes in Evansville:

These students will attend one-half day of classes. On a motion by Mrs. Mauck, seconded by Mr. Seibert, the motion unanimously carried.

# **Surplus Equipment**

Mr. Rapp informed the Board the storage building, located at North Posey High School, was very full of equipment and furniture that is no longer being used. Mr. Rapp recommended these items be declared "surplus equipment" by the Board. This action will allow the items to be sold. Mr. Rapp further recommended that the items be taken to the William Wilson Auction Realty, Inc., in New Harmony to be sold at auction. On a motion by Mrs. Mauck, seconded by Mr. Seibert, the motion carried unanimously. A copy of the items to be declared "surplus equipment" as approved by the Board shall be made a part of the official minutes by incorporation.
