Executive Session

The Board convened the Executive Session at 5:30 p.m. for the purpose of IC 5-14- 1.5-6.1 (9) to discuss job performance and evaluation of individual employees. The Board adjourned Executive Session at 6:40 p.m.

Regular Meeting

The Board of Education reconvened for the regular meeting at 6:51 p.m. with Board President, Larry Lewis calling the meeting to order with the initiation of the Pledge of Allegiance. Minutes of the previous meeting held on July 11, 2005 were submitted to the Board and approved on a motion by Mr. Bender, seconded by Mr. Baehl, and unanimously carried.

Claim Docket

A copy of the current claim docket was presented to the Board for consideration. Upon a motion made by Mrs. Mauck, seconded by Mr. Seibert, the claim docket was approved by the Board with a 5 to 0 vote. A copy of the claim docket shall be made a part of the official minutes by incorporation.

New Business

Mr. Wood passed out the proposed 2006 budget and asked permission to publish the required forms; Form 3, CPF, and Bus Replacement. Mr. Baehl made a motion to approve the request and Mrs. Mauck seconded the motion. The motion carried with a 5 to 0 vote.

Mr. Camp passed out the 2005-2006 fuel bids and recommended to the Board to continue to use Rutledge Oil for all fuel needs. Rutledge Oil was the lowest bid and they continue to provide good service. The motion carried 5 to 0.

Mr. Wood and Mr. Lewis presented to the Board an update on the roof damage and repair schedule at North Elementary. No action was necessary.

Mr. Wood presented Jane Reising's request to hold 5th and 6th grade volleyball league at NPHS. This league has been provided for the past nine years. The league will be scheduled at the two high school gyms from September 10 thru October 22, 2005. Mr. Seibert made a motion to approve the request and Mr. Bender seconded the request. The motion was approved 5 to 0.

Mr. Wood asked the Board to approve Mrs. Crick's request to employee Jill Kuepker as boys and girls cross country coach for the 2005 season. Mr. Seibert made a motion to approve the request and Mr. Bender seconded the motion. The motion carried 5 to 0.

Mr. Wood asked the Board to approve Mrs. Crick's request to employee Cody Elless and Michael Travers as co-coaches for boys' tennis. They will split the salary. Mr. Baehl made a motion to approve the request and Mr. Seibert seconded the motion. The motion carried with a 5 to 0 vote.

Mr. Wood asked the Board to approve Mrs. Crick's request to hire InSuk Granholm on a temporary contract as North Posey High School English teacher for the 2005-06 school year. Mr. Bender made a motion to approve the request and Mr. Baehl seconded the motion. The motion carried 5 to 0.

Mr. Wood asked the Board to hire Lynn Clark ½ time as a Speech Therapist and Cindy Rogge full time as a Behavior Therapist. MSD of North Posey County supports these positions with Posey County Special Services. Mr. Seibert made a motion to approve the request and Mrs. Mauck seconded the motion. The motion carried 5 to 0.
