The Board convened the Executive Session at 5:30 p.m. in the Metropolitan School District of North Posey Conference Room to discuss the assessment of upcoming security plans, prospects for commercial projects agents, and to receive information about prospective employees. The Board adjourned Executive Session at 6:41 p.m.

Regular Meeting

The Board of Education convened for the regular meeting at 6:50 p.m. with President, Geoff Gentil, calling the meeting to order with the initiation of the Pledge of Allegiance.

Mr. Schmitt made a motion to approve the consent items as presented and Mrs. Will seconded the motion. The motion passed 5 to 0.

New Business

Mr. Galvin presented for consideration the two options of policy for Electronic Participation by School Board Members in School Board Meetings. Mr. Oakley made a motion to approve the second option of the policy and Mr. Schmitt seconded the motion. The motion was approved with a 5 to 0 vote.

Mr. Galvin presented for consideration the contract from Curriculum Associates for the Toolbox. The contract cost is \$5,610.00 and will be paid through ESSER III grant to assist teachers in improving student skills on the i-Ready assessments. Mr. Kahle made a motion to approve the request and Mr. Schmitt seconded the motion. The motion was approved with a 5 to 0 vote.

Mr. Galvin presented for consideration the request from Food Service to increase the adult prices to \$2.50 for breakfast and \$4.60 for lunch. These increases are required due to the approval of the waiver for free breakfasts and lunches for our students. Mrs. Will made a motion to approve the request and Mr. Kahle seconded the motion. The motion was approved with a 5 to 0 vote.

Mrs. Walden presented to the Board for consideration the additional request from Food Service to increase the extra entrée with meal purchase and the entrée only purchase by \$0.25. This would make the cost of the extra entrée with meal purchase \$1.75 and the entrée only purchase \$2.00. Mrs. Will made a motion to approve the request and Mr. Kahle seconded it. After much discussion, the motion was opposed with a 0 to 5 vote. Upon a motion by Mr. Schmitt and seconded by Mr. Kahle, the Board asked Mrs. Walden to collect further information and they would reconsider during the September meeting.

Mr. Galvin presented for consideration the contract to secure an Architectural Firm for development of recommendations for facility improvements for the 2024 bond. Mr. Oakley made a motion to table the request and Mr. Schmitt seconded the motion. The motion was tabled for the September meeting.

Mr. Galvin presented an overview explanation of 2022 Budget. He then asked the Board permission to publish the 2022 Budget on Gateway. Mrs. Will made a motion to approve the request and Mr. Oakley seconded the motion. The motion was approved with a 5 to 0 vote.
