## **Regular Meeting**

The Board of Education convened for the regular meeting at 6:30 p.m. with President, Geoff Gentil, calling the meeting to order with the initiation of the Pledge of Allegiance.

Mr. Schmitt made a motion to approve the consent items as presented and Mrs. Will seconded the motion. The motion passed 4 to 0.

#### **New Business**

Mr. Galvin asked the Board to take from the table the proposal submitted by Mr. Fisher in the February 14<sup>th</sup> meeting regarding Physical Education credit replacement. Mr. Oakley made a motion to take the proposal from the table and Mr. Schmitt seconded the motion. The motion was approved with a 4 to 0 vote. Mr. Galvin then reported to the Board that Mr. Fisher wishes to postpone the discussion and request for approval at this time. No further action is needed from the Board at this time.

Mr. Galvin presented for consideration the preliminary proposal for Summer School 2022 to offer Category I summer school classes at all locations. The Department of Education defines Category I classes as Reading for grades 1-3 and any course that counts towards graduation, including Electives, for grades 9-12. The corporation will require the state minimum of at least 15 to 1 teacher to student ratio to offer the classes. Mrs. Will made a motion to approve the request and Mr. Schmitt seconded the motion. The motion was approved with a 4 to 0 vote.

Mr. Galvin requested the Board amend an approval made during the February 22, 2022 special meeting. During that meeting, the Board approved the South Terrace Insulation Project to be paid using the Operations Fund. Mr. Galvin asked the Board to consider allowing that cost to instead be paid from remaining the 2019 South Terrace Bond funds. The current unencumbered balance in that fund is \$48,153.69. Mr. Schmitt made a motion to approve the change and Mr. Oakley seconded the motion. The motion was approved with a 4 to 0 vote.

Mr. Galvin presented for consideration the 2022 Summer Capital Projects. Mrs. Will made a motion to approve the request and Mr. Schmitt seconded the motion. The motion was approved with a 4 to 0 vote.

Mrs. Walden presented for consideration the proposal to implement a two-year contract with Transfinder beginning with the 2022-2023 school year at the cost of \$9,490.00 for the first year, and \$5,850.00 the second year, to be paid from the Operations' Fund. Mr. Schmitt made a motion to approve the request and Mr. Oakley seconded the motion. The motion was approved with a 4 to 0 vote.

Mr. Galvin presented for consideration the Approval and Reinstatement Resolution for the 401(a) Plan, IRS Opinion Letter, and Adoption Agreement. Mrs. Will made a motion to approve the request and Mr. Schmitt seconded the motion. The motion was approved with a 4 to 0 vote.

Mr. Galvin presented for consideration the bids for North Posey Junior High School Boiler Replacement project. Sealed bids were opened in the Board Office on Thursday, March 3, 2022 at 1:00 p.m. Bids were received from four bidders; Deig Brothers, Alpha Mechanical, Harrell-Fish Inc., DeBra-Kuempel, and Melkay. The Stenftengal Group submitted the Bid Summary Sheet and their recommendation for the Board to review.
