Held August 28, 1972

A regular meeting of the Board of Education of the Metropolitan School District of North Posey County, Indiana, was held in the office of the Superintendent of Schools on the 28th day of August, 1972 with all Board Members present. Also attending were Superintendent Hollen, Administrative Assistant Wilson, and Attorney Schuler.

The meeting was called to order by President Fletchall, who presided. Minutes of the previous meeting of August 14 were read to the Board and approved as read.

Claims No. 90 through No. 108 in the total amount of \$2,289.06 were presented to the Board for consideration, and upon motion made by Hall, seconded by Tenison, and unanimously carried, were approved by the Board and ordered paid.

The Superintendent reported to the Board that Mrs. Linda Riley has been hired to teach choral music in the Jr-Sr High School; that the roof repairs at South Terrace school were about completed, but that certain problems of standing water and wet insulation had yet to be dealt with; and that additional applications for student transfer to North T & I School had been received, and that of these, one should be granted as the request was indicated to the school administrative staff prior to July 1, and the other should be denied since application was not made prior to July 1. This determination was approved by the Board.

A letter from the State Board of Health regarding the sanitation plants was read to the Board, and considered by it.

The Superintendent reported on the ordering of lightning arrestors for use at the high school sanitation plant from Althoff-Howard Company at an estimated cost of \$642.00.

Mr. Wilson gave a report on transportation problems and correction, and the Superintendent reported on the probable enrollment for the coming year indicating that it would slightly under that of last year.

Following a general discussion of other school matters, upon motion made and seconded, the meeting adjourned at 9:25 p.m.
