Minutes of Regular Meeting of the Board of Education of the Metropolitan School District of North Posey County, Indiana

Held on February 9, 2004

A regular meeting of the Board of Education of the MSD of North Posey County, Poseyville, Indiana, was held in the boardroom at the office of the Superintendent of Schools on February 9, 2004. The meeting began at 5:30 p.m. The following Board members were present:

Executive Session

The Board convened the Executive Session at 5:30 p.m. for the purpose of IC 5-14-1.5-6.1 (2a) to discuss strategy with respect to collective bargaining: (2b) to discuss initiation of litigation that is either pending or has been threatened specifically: and (9) to discuss a job performance evaluation of individual employees. The Board adjourned Executive Session at 6:33 p.m.

Regular Meeting

The Board of Education reconvened for the regular meeting at 6:47 p.m. with Board President Larry Lewis calling the meeting to order with the initiation of the Pledge of Allegiance. Minutes of the previous meeting, held on January 12, 2004, were submitted to the Board and approved on a motion by Mr. Baehl, seconded by Mr. Seibert and unanimously carried.

Claim Docket

A copy of the current claim docket was presented to the Board for consideration. Upon a motion made by Mrs. Mauck, seconded by Mr. Bender, the claim docket was approved by the Board with a 4 to 1 vote. Mr. Baehl voted against approval of the docket with dissension pertaining to a consultant fee of \$900.00 on the docket. A copy of the claim docket shall be made a part of the official minutes by incorporation.

Old Business

Mr. Wood discussed with the Board why we need to move on the construction and bond money to set up projects to complete this summer. Projects that were discussed were: a new track, a new water tank, resurfacing the concrete that has been destroyed, and building a new maintenance building. Mr. Wood will get approximate costs for further discussion.

New Business

Mr. Wood asked the Board for permission to begin the legal process on refinancing the 1994 bonds. This will generate tax-free money to use on capital projects and technology. Mr. Bender made a motion to allow Mr. Wood to move forward in the legal process to refinance the bonds. Mr. Baehl seconded the motion. The motion carried with a 5-0 vote.

Mr. Wood asked the Board for permission to allow Mr. Swartzentruber to use the NPHS baseball field for the spring 7th and 8th grade feeder league program. The field may need to be used on Sunday to make up rained out games. Mr. Baehl made a motion to accept the request and Mr. Seibert made a second. The motion carried with a 5-0 vote.

Mr. Wood stated that Stan Campbell, Carnegie librarian, was asking for names of people to contact to fill a position at the library. The Board was asked if they had any names to be passed on to help Stan in his search. The Board provided the names of Lisa Scheller and Rebecca Coleman. Mr. Wood will forward the names.

Personnel

Mr. Wood asked the Board to accept Waynette Westerfield's request for retirement at the end of the 2003-2004 school year. Mrs. Mauck made a motion to accept the request and Mr. Baehl seconded the motion. The motion carried 5-0.

Mr. Wood asked the Board to accept the maternity leave request of Chandra Gauer. She is asking for 6 weeks of leave beginning March 29, 2004. Mr. Bender made a motion to accept the request and Mr. Baehl seconded the request. The motion carried 5-0.

Mr. Wood asked the Board for permission to accept the employment of Summer Roedel as special education instructional assistant. She will be shared between the junior high and South Terrace for the remainder of the 2003-2004 school year. The position was created with special education money made available by Posey County Special Services. Mrs. Mauck made a motion to accept the request and Mr. Seibert seconded the motion. The motion carried 5-0.

Mr. Wood asked the Board to approve Nancy Scherer's request for Family Medical Leave due to her husband's illness. The leave will be from February 9, 2004 to April 30, 2004. Mr. Baehl made a motion to accept the request and Mr. Seibert seconded the request. The motion passed 5-0.

Volunteer Coaches

Mr. Wood recommended accepting Justin Scheller and Jesse Gehlhausen as volunteer track coaches for the 2004 track season.

Mr. Wood recommended accepting Kevin Wassmer and Brian Schmitt as volunteer golf coaches for the 2004 golf season. Mr. Seibert made a motion to accept the recommendation, seconded by Mr. Baehl. The motion carried with a 5-0 vote.
