Minutes – Regular Meeting of the Board of Education of the Metropolitan School District of North Posey County, Indiana

November 10, 2014

A meeting of the Board of Education of the MSD of North Posey County, Poseyville, Indiana, was held in the Board office of MSD of North Posey County on November 10, 2014. The following Board members were present:

Executive Session

The Board convened the Executive Session at 5:30 p.m. for the purpose of IC 5-14- 1.5-6.1 (9) to discuss job performance and evaluation of individual employees. The Board adjourned Executive Session at 6:25 p.m.

Regular Meeting

The Board of Education convened for the regular meeting at 6:30 p.m. with Board President, Steve Bender, calling the meeting to order with the initiation of the Pledge of Allegiance. Minutes of the previous meeting were presented to the Board for October 15, 2014. Upon a motion made by Mr. Scarafia and seconded by Mr. Neidig, the minutes were approved with a 5 to 0 vote.

Claim Docket

A copy of the claim docket for the period of October 15, 2014 to November 10, 2014 was presented to the Board for consideration. Upon a motion made by Mr. Neidig, seconded by Mr. Gentil, the claim docket was approved with a 5 to 0 vote. A copy of the approved claim docket shall be made a part of the official minutes by incorporation.

New Business

Dr. Wannemuehler and Dr. Camp presented information to the Board regarding the upcoming 2015 ISTEP+ assessment and the guidance we are receiving from the DOE and Superintendents' Association. The DOE is predicting a drop in scores across the state due to several factors. They are offering strategies to reduce the amount of the decrease. Dr. Wannemuehler also discussed of our outstanding results on our A-F Report Card recently announced by the DOE. All North Posey schools received "A" ratings for the 2013-2014 school year. Dr. Wannemuehler, Dr. Camp, and the Board expressed how proud they are of our North Posey students' academic performance and growth on Indiana state assessments. They stated that success like this is achieved through a

collaborative effort of hard working teachers, students, administrators, staff, supportive parents, and an involved community.

Dr. Wannemuehler presented a request to the Board to accept the grant awarded by Posey County Community Foundation in the amount of \$5,500.00. The grant dollars are to be used to fund the Bully Awareness and Prevention Program at both elementary schools. MSD of North Posey County will partner with Youth First Services to provide training and implementation of the program. Upon a motion made by Mr. Neidig and seconded by Mr. Scarafia, the acceptance of the grant was approved with a 5 to 0 vote.

Dr. Camp presented to the Board the proposed Guaranteed Energy Savings Contract projects and explained the method recommended to fund the projects. Dr. Camp is proposing to fund the projects with funds from Rainy Day as well as loans from Community State Bank and another bank yet to be determined; total cost is anticipated to be approximately \$2,800,000.00. The terms of each loan shall be \$1,000,000.00 paid over 7 years at 1.9%; with the ability to pay off early with no penalty. Upon completion of the projects, payments will be made to the banks from the Capital Projects Fund. Upon a motion made by Mr. Gentil and seconded by Mrs. O'Risky, the projects were approved with a 5 to 0 vote. A copy of the projects and the amortization schedule will be made part of the minutes by incorporation.

Dr. Camp asked the Board to approve the following facility use requests:

- Larry Williams, on behalf of the "Old Men Basketball Club, requests to use the North Elementary multi-purpose room once a week from November 5, 2014 March 18, 2015 from 6:00 p.m. to 8:00 p.m.

Upon a motion made by Mrs. O'Risky and seconded by Mr. Scarafia, the facility use requests were approved with a 5 to 0 vote.

Dr. Camp asked the Board to approve the request for an overnight trip for the NPHS Spell Bowl team who have advanced to the State Competition on November 14-15, 2014 in Lafayette, IN. Upon a motion made by Mrs. O'Risky and seconded by Mr. Neidig, the request was approved with a 5 to 0 vote.
