Executive Session

The Board convened the Executive Session at 5:01 p.m. for the purpose of IC 5-14- 1.5-6.1 (9) to discuss job performance and evaluation of individual employees. The Board adjourned Executive Session at 6:17 p.m.

Regular Meeting

The Board of Education convened for the regular meeting at 6:35 p.m. with Board President, Geoff Gentil, calling the meeting to order with the initiation of the Pledge of Allegiance. Minutes of the previous meetings were presented to the Board for April 13 and May 7, 2015. Upon a motion made by Mrs. Will and seconded by Mr. Schmitt, the minutes were approved with a 5 to 0 vote.

Claim Docket

A copy of the claim docket for the period of April 13, 2015 to May 11, 2015 was presented to the Board for consideration. After some discussion regarding the claims for supply orders and the claim to St. Phillips, a motion was made by Mr. Oakley and seconded by Mr. Stock. The claim docket was approved with a 5 to 0 vote. A copy of the approved claim docket shall be made a part of the official minutes by incorporation.

New Business

Mr. Gentil turned the meeting over to Senator Jim Tomes. Senator Tomes gave a brief speech and then opened the meeting for a question and answer session.

Dr. Wannemuehler officially announced to the Board that North Posey High School, North Elementary and South Terrace were among the 281 schools in Indiana that achieved the Four Star Schools award for 2013-2014. Schools must be in the top 25th percentile in two ISTEP-based categories, must have earned an "A" in the state's accountability system and be accredited by the Indiana Department of Education. This award is a testament to the excellence of our teachers, administrators, students, and parents. In addition, Dr. Wannemuehler reported that the iRead scores have been announced and 99% of our students passed. This too is a great accomplishment for our teachers, administrators, students, and parents.

Dr. Camp requested the Board declare the presented surplus lists, prepared by each building's technology department, of various items that are no longer supported or of no value to the corporation. Eric Long and Danny Ellis have located a vendor to secure data will be destroyed and prepared for recycling. Mr. Oakley made a motion to approve the request and Mrs. Will seconded the motion. Mr. Schmitt made a motion to approve the requests and Mrs. Will seconded the motion. The motion carried 5 to 0.

- Matt Schenk requests to use the parking lot at South Terrace on July 28 30 to park cars for their field day.
