The Board of Education convened for the regular meeting at 5:34 p.m. with Geoff Gentil calling the meeting to order with the initiation of the Pledge of Allegiance.

Mr. Gentil opened the meeting to conduct a public hearing on the proposed 2019 school budget. Dr. Camp gave an explanation to the Board regarding the budget process and the changes that will occur with the 2019 budget.
