## Regular Meeting

The Board of Education convened for the regular meeting at 6:40 p.m. with President, Geoff Gentil, calling the meeting to order with the initiation of the Pledge of Allegiance.

## Minutes, Claim Docket and Consent Items

Mr. Schmitt made a motion to approve the consent items as presented and Mr. Kahle seconded the motion. The motion passed 4 to 0. Mr. Galvin and the Board expressed their gratitude to Mrs. Farrar for her 24.5 years of service with MSD of North Posey County.

#### **New Business**

Mr. Galvin presented for consideration to create the following positions: Director of Special Education, Administrative Assistant for Special Education, and School Psychologist. Mr. Oakley made a motion to approve the request and Mr. Kahle seconded the motion. The motion was approved with a 4 to 0 vote.

Mr. Galvin presented for recommendation a proposal to pay a stipend to the following employee groups corresponding to the Teacher Appreciation Grant: Administrators, Classified Employees, School Counselors, ELearning Coach, Food Service, and Bus Drivers.

Mr. Kahle made a motion to approve the proposed stipends and Mr. Schmitt seconded the motion. The motion was approved with a 4 to 0 vote.

Mr. Galvin presented for consideration the Hafer Architectural Contract for the Renovation of the North Posey High School/North Posey Junior High School Life Skills Classrooms 108 and 109 with Special Education ARPA funds and Operation Funds. Mr. Schmtt made a motion to approve the request and Mr. Oakley seconded the motion. The motion was approved with a 4 to 0 vote.

Mr. Galvin presented for consideration the MOU for Data Sharing with SIEC and MSD of North Posey County. Mr. Oakley made a motion to approve the request and Mr. Kahle seconded the motion. The motion was approved with a 4 to 0 vote.

Mr. Galvin presented for consideration the request from Sean Fisher to close the credit cards through Fifth Third Bank that are currently assigned to North Posey High School. Upon the closing of these accounts, North Posey Junior High would need to maintain the credit card accounts exclusively on their own with respect to availability, utilization, bill payment, fees, etc. associated with the credit card account if they wish to keep the account open. Mr. Kahle made a motion to approve the request and Mr. Oakley seconded the motion. The motion was approved with a 4 to 0 vote.

Mr. Galvin presented for consideration the request from Steven Kavanaugh to pursue a grant that would provide the equipment and the training for four (4) teachers needed to start an archery club as well as teach all junior high students archery in our physical education classes. The junior high would need to pay a balance of \$500.00 and be willing to teach archery during the school day for at least 10 school days. Mr. Schmitt made a motion to approve the request and Mr. Oakley seconded the motion. The motion was approved with a 4 to 0 vote.
